## Week 2, Legislative Days 6-10

This week, the Georgia General Assembly met Monday through Friday for Legislative Days six through ten of the 2024 Session. With over thirty committee meetings scheduled over the course of the week, the Legislature was in full swing with multiple prominent issues arising such as election regulations, anti-semitism, early education funding, school choice, and the legalization of sports betting. Keep reading for a breakdown of the week!



#### **Election Bills**

This session, there will be significant attention toward elections and how the state handles these processes. Several bills have been introduced from both the House and Senate to combat concerns with election processes.

In the Senate Ethics committee on Thursday of this week, Senator Burns presented two separate bills concerning elections. Senate Bill 189 tackles text portions of ballots that are for vote tabulation and recounts purposes. This bill will effectively eliminate QR codes from the text portion of the ballot only. This bill does not impact absentee ballots, except for still having a code to identify precinct. No voter selection in any way is included in that code. These changes will require the state to organize and acquire different scanners to complete this new task, and the fiscal note for these new scanners is an estimated \$15 million for those scanners. This measure, after much discussion, did pass the committee and will be moved onto the Senate rules for determination of when to be heard by the chamber.

Senator Burns presented Senate Bill 212 as his second presentation in the Senate Ethics committee. This bill aims to work on Probate Court Judges related to elections, and this hearing focuses on the substitute for the bill. The intention of this bill is to change the jurisdiction of elections to the local Boards of Election and away from Probate Court Judges. This bill would affect the 29 counties that used Probate Court Judges for elections last year with the absence of local Board of Election help. SB 212 would remove any payment for running elections, and it will go into effect January 1st, 2025 if passed.

In a House Government Affairs meeting on Wednesday, the committee heard two House bills concerning elections. Representative LaHood is sponsoring House Bill 976, and this bill pushes a similar platform to Senator Burns' bills he presented a day after this presentation. This bill focuses on ballots used in optical scan voting systems, and the systems will use paper with a visible watermark for security purposes. Most counties in Georgia would be able to use their current ballot inventory for the primary season, but the updates would require

changes going forward. This change has an estimated cost between \$100 and \$100 thousand. This bill passed out of the committee unanimously.

House Government Affairs also heard House bill 974, another bill presented by representative LaHood. This bill deals with the Secretary of State, and it looks to establish and hold a state-wide system for posting scanned paper ballots. This bill was heard briefly, but it is being held as it needs more time to continue refining the work.

#### Anti-Semitism in Georgia

This week, the legislature heard HB 30, legislation concerning anti-semitism in the state. Representative John Carson is the sponsor for the bill, and there was widespread support for the new bill. This legislation, if adopted, would incorporate a new definition of antisemitism into Georgia's law which is drawn from the International Holocaust Remembrance Alliance, and it has been widely accepted by many states and organizations around the country. This bill was presented last year during the previous session, however the bill was stalled in a debate over the wording.

HB 30 was heard on the Senate floor on Thursday, January 25th. All across the state, this bill has been contentious. Many parties have their take on the bill, and it has caused a lot of tension in Georgia. Republicans are increasing support for Israel, so this bill has caught traction with their supporters. On the other hand, several groups are opposed to this legislation. Groups like American Civil Liberties Union and Georgia's charter of the Council on American Islamic Relations are both critical of the bill and the precedent it sets. They worry that codifying specific legislation for a specific group of people may not be inclusive of other minority groups. Overall, each group can agree that the anti-semitism and general hate in Georgia needs to be combatted, and this bill is yet another attempt to counter that hatred.

After much debate over the bill, it ended up passing with a majority of 44-6. The specific bill passed by the Senate was a substitute, or a slightly altered version of what the House passed, so the bill was transmitted immediately to the House. If the House of Representatives passes the Senate substitute, the bill will then be transmitted to Governor Brian Kemp for a signature.



#### **School Choice and Early Education Funding**

The Senate Education Committee heard multiple bills on Tuesday of this week, the most notable being SB 147. Sponsored by Senator Still and known as the "Boundless Opportunities for Georgia Students Act," SB 147 aims to ensure that county and city boundaries do not limit opportunities for students in the state. Notably, the bill establishes a floor of \$10,000 per student in the public school system and prohibits fund transfers that

would cause the budget to fall below this threshold. The bill would allow students the choice to leave their school district to attend other public schools outside of their area if the school has space. Despite some division, the committee approved SB 147 with a 4-2 vote, to foster equal opportunities for students across Georgia.

In a recent presentation before the House Education Committee, Pro Temp Jan Jones, representing the Early Learning Study Committee, outlined findings and recommendations that carry an estimated annual cost of approximately \$100 million. The primary recommendation involves a reduction in class sizes from an average of 25 to 20, aligning them more closely with K-5 class sizes. Additionally, the proposal suggests increasing the salaries of assistant teachers and lead teachers to match the pay scale of non-pre-K teachers, with assistant teachers seeing a raise from a \$20,000 salary to around \$25,000. Furthermore, the presentation advocated for boosting transportation funds for pre-K students to match the average funding received by K-12 students, which is approximately \$80 per child per year. Another key aspect involves an increase in capital construction costs, proposing that public school pre-K classes qualify for state capital construction funds. It was recommended that all these financial additions be funded through lottery funds.

During a presentation to the House Education Appropriations Committee, the Department of Early Care and Learning (DECAL) outlined key changes to the amended budget. Notable adjustments include an increase in the nutrition budget, with a focus on fostering partnerships with nonprofits and sponsors to address barriers to food service in underfunded areas. Additionally, there is a proposed increase in employer rates within the Pre-K budget. The budget for the Summer Transition Program, a five-week initiative designed to support rising K-5 or Pre-K students in need of additional assistance, is set to see an expansion. Lastly, the presentation highlighted a planned computer refresh for Pre-K staff to update technological resources in early education.

#### **Sports Betting**

Late Wednesday evening, a group of bipartisan leaders in the Senate introduced a new bill on sports wagering. This measure's sponsors include Senate Education Chairman Clint Dixon, Senate Minority Leader Gloria Butler, Governor Floor Leader Bo Hatchett, among others. The bill has received support from the Metro Atlanta Chamber of Commerce, Atlanta's professional sports teams and a nod from Lieutenant Governor Burt Jones. Having a strong coalition of both Democrats and Republicans will be necessary in garnering passage of the measure, with it failing numerous times in past legislative sessions. The funds collected from the measure will be administered by the Georgia Lottery Corporation with the proceeds going towards the HOPE Scholarship, pre-k programs and needs-based student aid. Supporters have estimated that sports betting would bring anywhere from \$30 million to \$100 million in taxes or fees to the state each year.

### **Education Legislation**

The Senate Education Committee heard multiple notable bills on Tuesday of this week, each addressing key aspects of education funding and opportunities in Georgia. SB 208, the bill associated with SR 189, focuses on the implementation of fees for education under the Georgia Development Impact Fee Act. The committee unanimously passed SB 208. Additionally, SR 189, a constitutional amendment also sponsored by Senator Dolezal, proposes the establishment of development impact fees specifically allocated for educational purposes. The committee, once again, reached a unanimous decision in favor of SR 189.

In the House Education Appropriations Subcommittee this week, several key presentations were made by various agencies in addition to the one highlighted above. The Department of Education (DOE) addressed fund adjustments for Burke County, supplements to the Quality Basic Education (QBE) budget, and an increased charter school supplement due to additional charter schools in the state. Notably, a restoration budget was proposed for the Mountain Education Charter High Schools, focusing on the completion of this non-traditional 9-12 program. The Employees' Retirement System (ERS) presentation outlined a \$500 million allocation to achieve an 80% funding goal, providing a buffer for market downturns and improving cost-of-living adjustments for ERS retirees. The Governor's Office of Student Achievement (GOSA) reported changes including the reinstatement of supplements for four programs and a \$135k increase for two additional dashboards, dedicated to tracking literacy data and workforce outcomes for Georgia students.

### **Healthcare Legislation**

In this week's Senate Health and Human Services Committee, the Georgia Trauma Care Commission presented a Trauma System Stabilization Proposal. The presentation highlighted significant improvements in treating severely injured patients, with 93% treated at a Designated Trauma Center (DTC) in 2020 compared to 64% in 2011. Despite progress, the Trauma Center Readiness Costs have risen considerably, creating a funding gap. The proposal recommended allocating 50% of the total readiness costs, amounting to \$61.7 million, for all four trauma center levels. Additionally, during the committee meeting, HB 343 by Rep. Newton, concerning the regulation and licensure of pharmacy benefits managers, faced a setback as it failed to pass the committee vote by 8-5.

### **Local Legislation**

SB 349, sponsored by Chairman Hufstetler, is set to be heard soon in the Senate Finance Committee. This proposed legislation focuses on the ad valorem taxation of property by aiming to revise provisions related to the setting of millage rates, limit the application of freezing the assessed value following an appeal, and restrict the temporary reduction in taxes for taxpayers who appeal to superior court but do not participate in settlement conferences. Additionally, SB 349 introduces a statewide homestead exemption, equivalent to the amount by which the current year assessed value exceeds 3 percent of the adjusted base year value of the homestead.
